3. System Update Procedure

The system update consists of three stages:

- Code update,
- Data update,
- Update of printed forms and reports created using the <u>Electronic Reporting</u> (ER) functionality.

A code update involves transferring changes in objects from the release to the customer's database by deploying a package containing the updated program code. More details on this approach can be found in <u>Microsoft's documentation</u>.

A data update involves modifying existing data when a new release changes the data schema or introduces new configurations. Changes to existing or new data structures occur automatically during the code update. However, configuring new modules is done manually within Dynamics 365 or by importing data from pre-prepared files using the Data Management functionality.

ER report and printed forms update required check after version installation. If needed for proper work of ER templates, formats should be deleted, models or reports and printed forms should remain, templates of reports and printed forms should be reimported from provided xml files, templates of reports and printed forms in xls format should be imported into newly created configurations in «Draft» status and finalized via «Complete» button.

4. Terms of SMART Accounting for Ukraine Updates

- 1. SMART business (hereinafter referred to as the "Company") develops and updates the SMART Accounting for Ukraine solution (hereinafter referred to as the "Solution") in accordance with the requirements and limitations defined in the Microsoft Dynamics Partner Localization and Translation Licensing Program (PLLP).
- 2. The Company publishes updates to the Solution semiannually on the first business day of the update cycle. The Company reserves the right to change the update frequency in the future. Updates are provided free of charge to customers with an active subscription for Microsoft Dynamics 365 Finance and Operations Applications, as long as the product remains in its main support period by Microsoft.
- 3. The update process for the customer's system is carried out based on a pre-agreed update schedule, including the scope of work for migrating the update, system configuration updates, and testing. The update must be completed no later than the release of the next scheduled update. The estimated update cycle is every six months. Postponing an update for up to six months is allowed upon prior agreement.
- 4. Customers also have the option to update their system independently. For this purpose, the Company provides an update package, including system configuration recommendations and data update scripts. However, customer-specific modifications to the system may be incompatible with the update source code, which means that either the update or the modifications may require adaptation.
- 5. The Company provides bug fixes for the Solution free of charge to customers with an active subscription, provided they apply updates in a timely manner as outlined in Clause 4.
- 6. The Company provides a detailed description of changes in each update and publishes it no later than the update release date.
- 7. Urgent legislative updates or critical bug fixes are provided to customers outside the standard update schedule.
- 8. Updates to the Solution whether fully or for selected functionalities for "older" system versions that are no longer in Microsoft's main support period (per Clause 3) or do not have an active subscription are performed at the Company's discretion. In such cases, development is carried out specifically for the customer and may be subject to additional charges.
- 9. Any deviations from these update terms must be specified in the agreement; otherwise, these terms shall apply.
